<p><b>Service Detail</b></p> <p>This service will excise suspected skin cancers recommended for removal by the Waikato DHB's Tele-dermatology Service for New Zealand residents living in Waikato DHB. The service includes excisions of suspected skin cancer lesions in these areas:</p> <ul style="list-style-type: none"> <li>the trunk</li> <li>upper limb (including shoulder)</li> <li>lower limb (including hip)</li> </ul> <p>The patient will be contacted by the practice for an appointment and the excision completed within 14 days of referral. Follow up: the patient will under the care of the service until they have received follow up and are discharged. GPs providing this service:</p> <ul style="list-style-type: none"> <li>Dr Bryan MacLeod</li> </ul>
<p><b>Exclusion Criteria</b></p> <ul style="list-style-type: none"> <li>All skin lesions not recommended for removal by Tele-dermatology.</li> <li>Topical treatment and removal of suspected skin cancers by all methods which are not surgical excision.</li> <li>Suspected skin cancers of neck, scalp and face including ears and eyelids.</li> <li>Suspected skin cancers outside the competencies of the Primary Care Lesion Service.</li> </ul>
<p><b>Referral to include</b></p> <ul style="list-style-type: none"> <li>Copy of original referral to Waikato DHB's Teledermatology Service - attach from attachment button</li> <li>The referral reply recommending the excision of the lesion/s - attach from investigations tab.</li> <li>If patient is on anticoagulants</li> <li>Any mobility or impairments</li> <li>Current contact details for the patient</li> </ul>
